Detailed Description of the Product **R.C.C. Precast Prestressed Compound Wall Fencing.**

1. **Quoted Price:**

- a) The quotation shall be valid up to 10 Days for the above described product.
- b) The bidder shall quote for goods/ services in the attached format of quotation.
- c) All duties, taxes, F.O.R. and other levies payable by the bidder shall be included in the goods / services and shall stand final.
- d) The rates quoted for each good / service shall be fixed for the duration of the validity of the quotation and shall not be subject to adjustment.
- e) Corrections if any, shall be made by crossing out, initialing, dating and rewriting.
- f) The Prices shall be quoted in Indian Rupees only.

2. **Each bidder must submit only one quotation. Bidder shall not contact other bidders in matters related to this Quotation.**

3. **Validity of Quotations:**

The Quotation shall remain valid up to 10 Days after the deadline fixed for submission of quotation.

4. **Evaluation of Quotations:**

Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed, conform to the terms and conditions and specifications in the following manner.

- a. The evaluation will be done exclusive of GST.

5. **Award of contract:**

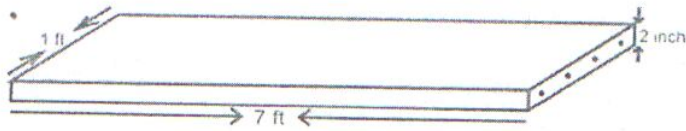

DESIGN OF COMPOUND WALL

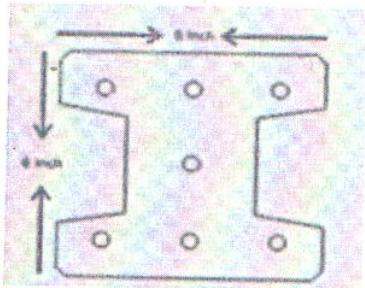
1 SAMPLE PICTURE OF COMPOUND WALL
