#### 1. Quoted Price:

- a. The contract shall be valid up to 31.12.23 for the products described above.
- b. The bidder shall quote for goods / services in the attached format only.
- c. All duties, taxes, F.O.R. and other levies payable by the bidder shall be included in the goods / services and shall stand final.
- d. The rates quoted for each good / service shall be fixed for the duration of the contract and shall not be subject to adjustment.
- e. Corrections if any, shall be made by crossing out, initialing, dating and rewriting.
- f. The prices shall be quoted in Indian Rupees only.
- g. The Work quantity may vary.
- h. Estimate is subject to change in future Orders.
- i. Bidder has to mention location (s) of work where service can be provided.

# 2. Each distributor must submit only one quotation with Panasonic Company distributor certificate. Distributor shall not contact other distributor on matters related to this Quotation

#### 3. Validity of Quotations:

The quotation shall remain valid up to 31.12.23

## 4. Evaluation of Quotation:

Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e., which are properly signed and conform to the following terms and conditions and specifications.

- a. The evaluation will be done exclusive of GST.
- b. The evaluation would be done for all the goods / services put together. The items for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly. We will award the contract to the responsive bidder whose total cost for all the items put together will be the lowest.
- c. Will Compare terms and conditions and specifications

### 5. Award of Contract:

- a. Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 4 (b) above.
- b. Purchaser prior to the expiry of the validity period of the quotation will notify the bidder whose quotation is accepted for award of contract. The terms of the accepted offer shall be incorporated in the Purchase Order or Work Order.
- c. Notwithstanding the above, purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations any time prior to the award of the contract.
- 6. Payment shall be made after 15 days of delivery of goods.
- 7. Normal commercial guarantee / warranty shall be applicable to the supplied goods.

# 8. Cost of Procurement Processing:

The bidder shall pay the "Tender Fee" of **Rs. 590/- (Including GST)** only through "SB Collect" system. Detailed process is enclosed as Annexure before submission of Bid. Mention Transaction No. and date while submitting Bid/Quotation.

## 9. Earnest Money Deposit:

EMD for this tender will be 2% of the total quoted cost. BAIF Nashik will compare all bids and the Purchase Committee will award a contract to L1. L1 will be informed of selection of supply of goods/ services by E-mail. L1 has to transfer EMD amount within 2 working days and provide Transaction No. and date by return E-mail. After confirmation of EMD amount deposit in BAIF bank account, BAIF will issue a Purchase Order / Work Order. In case of failure to pay EMD, BAIF Purchase Committee reserves the right to decide further course of action. The same will be refunded (interest free) after getting the work completion report of the total scope of work or guarantee/warranty period of at least one monsoon season period whichever is applicable. The earnest money shall be liable to be forfeited, if the successful bidder, after submitting the tender rescinds from or modifies the offer after the acceptance of tender.

After acceptance of Work Order/Purchase Order and payment of EMD, if work is not completed or material is not supplied within the validity of the Work Order/Purchase Order, Vendor will not be eligible for refund of EMD and will also not be eligible to participate in future tender process of BAIF for a period of one year.

# SB Collect - for Tender fees and EMD amount Collection

With immediate effect, Tender Fee and EMD Amount collections from bidders / vendors will be as under for all Tenders from BAIF Nashik:

- 1. No Cash / Cheque will be accepted
- 2. Vendor / Bidder who wish to participate in Tender process of BAIF Nashik has to make Tender Fee only through following online process before Tender opening meeting at BAIF Nashik
- 3. Purchase Dept. will inform the Vendor about selection as "L1" and then the Vendor has to make online payment of EMD and inform Transaction No. to the Purchase Dept. in Nashik.
- 4. Purchase Dept. will confirm from Nashik A/c Dept. regarding receipt of amount in BAIF SBI Nashik Bank A/c
- 5. Purchase Dept. will issue PO / WO to L1 Vendor
- 6. Accounts Dept. will issue receipt to all vendors against receipt of Tender Fee and EMD
- 7. Vendor / Bidder may or may not have bank A/c with State Bank of India i.e. SBI Account holder and SBI non-Account holder will also be allowed to make online payment.
