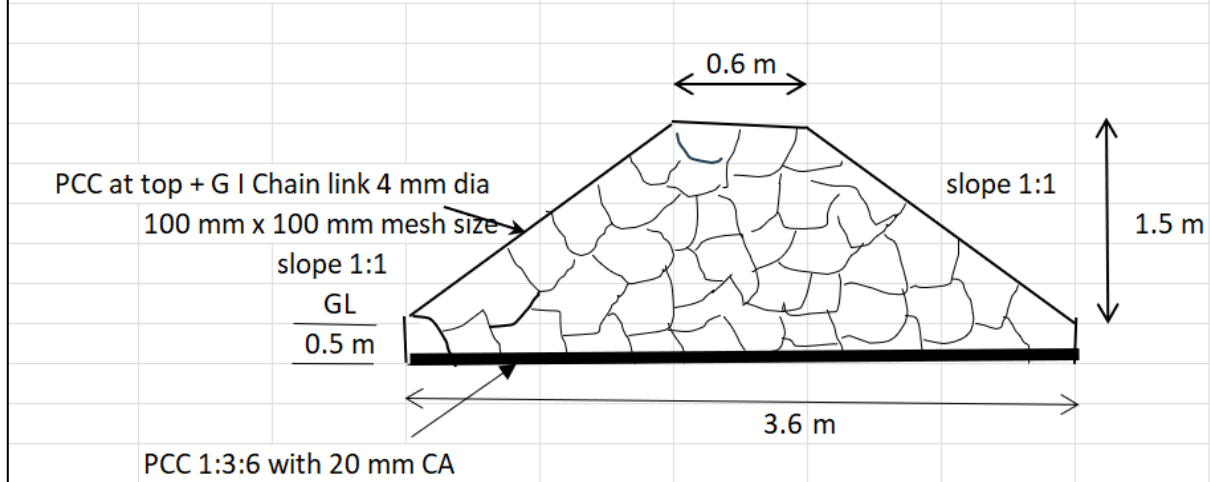

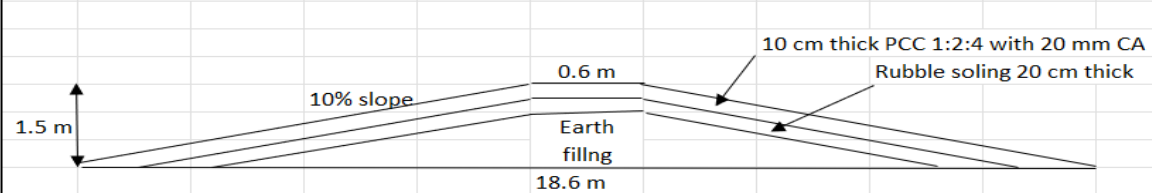

Cross section of Gabion wall

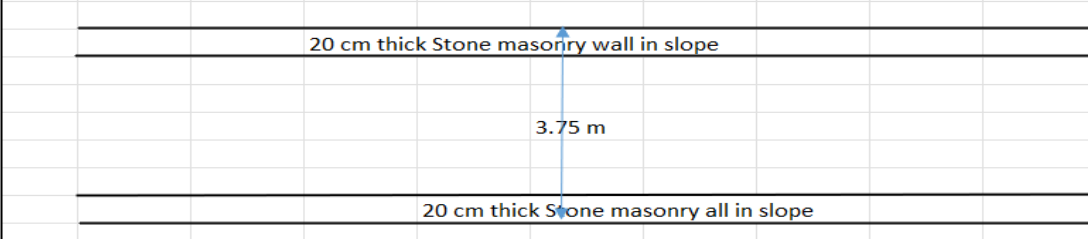


Ramp detail

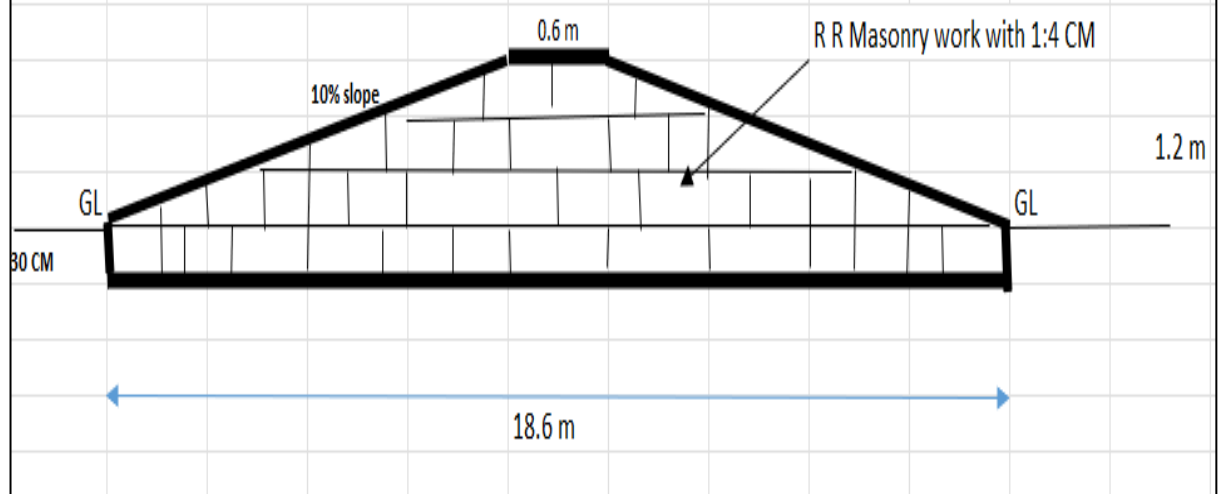
Cross section

Terms and Conditions:

1. Earnest money (**2% of Tender value**) shall be submitted along with tender through DD in favour of "**BAIF INSTITUTE FOR SUSTAINABLE LIVELIHOODS AND DEVELOPMENT, U.K.**" payable in Dehradun. Tenders will not be accepted without earnest money. The Earnest Money will be returned to unsuccessful tenderers within a reasonable time. The Earnest Money deposited by successful tenderer(s) will be retained towards the Security Deposit (Retained amount).
2. The rates offered by the Bidder/ Tenderer will be inclusive of all Taxes, License fees, Royalty, Octroi, Labour, Construction Materials, all Tools and Plants, Water, and Power required for satisfactory completion of the work.
3. That the rates are inclusive of GST or exclusive of GST should be mentioned clearly and the GST rate in % should also be mentioned.
4. The authority for the acceptance of the tender will rest with the organization. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer (s) shall demand any explanation for the cause of rejection of his/their tender nor will the organisation undertake to assign reasons for declining to consider or reject any particular tender or tenders.
5. The competent authority of the organisation for the acceptance of the tender reserves the right to divide the tender amongst more than one tenderer, if deemed necessary.
6. **Schedule of Payment:**

6.1 The Schedule of payment shall be decided through negotiation as per condition mentioned by successful tenderer in his tender.

6.2 The final payment shall be made on production of tax invoice for actual quantity of work done as per measurement taken by our Project Engineer after satisfactory completion of work.

7. In case of any mishap, injury or damage occurring at the site, it will be the responsibility of the Contractor.
8. **Penalty for delay in completion of work:** The organization may impose penalties for delay in completion of work except in case of natural calamities and law and order situation. The penalty amount shall be **Rs. 500 per day**. The tenderer must agree to bear the penalty amount in case of delay in completion of work.
