Before submitting the tender, the tenderer will also inspect the site of the Check Dam and acquaint herself or himself with the local conditions, means of access to the site of work, nature of work and all other matters pertaining thereto. The tenderer will be deemed to have satisfied herself or himself by actual inspection of the site and locality of the work.

Terms and Conditions:

1. The contractor must have their registration, GST registration and PAN No. The duly signed copy of each document shall be submitted along with the tender.

- 2. Earnest money (2% of Tender value) shall be submitted along with the tender through DD in favour of "BAIF INSTITUTE FOR SUSTAINABLE LIVELIHOODS DEVELOPMENT, U.P." payable at Prayagraj. Tender will not be accepted without earnest money. The Earnest Money will be returned to unsuccessful tenderers within a reasonable time.
- 3. The rates offered by the Bidder/ Tenderer will be inclusive of all Taxes, License fees, Royalty, Octroi, Labour, Construction Materials, Tools and Plants, Water and Power required for satisfactory completion of the work.
- 4. Mention clearly that the rates are inclusive of GST or exclusive of GST and also mention the GST rate in %.
- 5. The authority for the acceptance of the tender will rest with the organisation. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer (s) shall demand any explanation for the cause of rejection of her/his tender and nor will the organisation undertake to assign reasons for declining to consider or reject any particular tender or tenders.
- 6. None of the advance amount shall be given. The 70% amount of cost of materials supplied as site material shall be paid as an advance after submission of the bill of materials.
- 7. The payment may be made in the form of running bills for actual quantity of work done as per measurement taken by Project Engineer after satisfactory completion of the work.
- 8. The materials should be supplied at the site after the quality of the materials are checked and approved by our Project Engineer. The specification of materials is as given below:
 - Cement Ultratech, Coarse Sand Badausa, Stone ballast Kabrai / Bharatkoop, Bricks First class (as approved by Engineer).
- 9. Final payment will be made for actual quantity of work done as per measurement taken by Project Engineer after satisfactory completion of work. Excess quantity of work will not be considered. Hence, please maintain the same size of each item and quantity as given in the BOQ / Drawing.
- 10. The 5% amount will be retained as security deposit for 12 months period after completion of work. Any defect found in the structure will need to be repaired free of cost by the Bidder/Tenderer within a period of one year. The retained amount shall be refunded without any bank interest after free maintenance period.
- 11. After receiving the Work Order, you will be submitting a timeline for completion of work before or end date of work completion as mentioned in the Work Order.
- 12. In case of inferior quality of work or slow progress, the work order shall be cancelled.
- 13. The organisation may impose penalty for delay in completion of work except in case of natural calamities and law and order disturbances. The penalty amount shall be Rs. 500.00 per day.
- 14. That you will undertake the above-mentioned job as per BOQ and Drawing enclosed herewith.

- 15. The organisation reserves the right to change or amend the drawing, specification and scope of work as per need as and when necessary and shall be notified in advance.
- 16. That liability of labour/asset involved in the work with respect to injury/accident/insurance will be with your firm.
- 17. In case of any dispute regarding work, the decision of the State Head, BISLD-UP shall be final.
- 18. Any crossing out /overwriting in the bill shall not be accepted.
