Term & conditions:

1. The Vendor must have their registration, GST registration, and PAN. The duly signed copy of each document shall be submitted along with the tender.
2. Earnest money (2% of Tender value) shall be submitted along with tender through DD in favour of “**BAIF INSTITUTE FOR SUSTAINABLE LIVELIHOODS DEVELOPMENT, U.P.**” payable at Prayagraj. The tender will not be accepted without earnest money. The Earnest Money will be returned to unsuccessful tenderers within a reasonable time. The Earnest Money deposited by successful tenderer(s) will be retained towards the Security Deposit (Retained amount).
3. Security Deposit (retained amount) shall be refunded after the successful completion of 12 months.
4. **Defect liability period / Maintenance period:** The maintenance period will be of 36 months for each unit from the date of satisfactory completion of work. In case, if defects are found after the completion of work, the vendor shall immediately repair the defects free of cost up to **36 months** after completion of work. The vendor shall not claim any amount for repairing work.
5. The warranty period will be of **36 months**.
6. **Penalty for delay in completion of work:** The organization may impose a penalty for delay in completion of work except in case of natural calamities and law & order disturbances. The penalty amount shall be **Rs. 500.00/day**. The tenderer must agree for bearing a penalty amount for the delay in the completion of work.
7. The rates offered by the Bidder/ Tenderer will be inclusive of all Taxes, license fees, Royalty, Octroi etc. labour and construction Materials, all Tools & Plants, water & power required for satisfactory completion of the work.
8. In case of any mishappening, injuries or damage occurring at the site, it will be the responsibility of the Vendor.
9. Mention clearly that the rates are including GST or exclude GST and mention the GST rate in %.
10. All payment will be paid after satisfactory work completion.
11. Minimum turnover Five crores average (in Previous three Financial Year report attached).
12. Minimum 3 work experience in similar field of solar street light (Report attached).
13. The authority for the acceptance of the tender will rest with the organisation. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer (s) shall demand neither any explanation for the cause of rejection of his /their tender nor the organisation undertakes to assign reasons for declining to consider or reject any particular tender or tenders.
14. The competent authority of the organisation for the acceptance of the tender reserves the right to divide the tender amongst more than one tenderer, if deemed necessary.
