

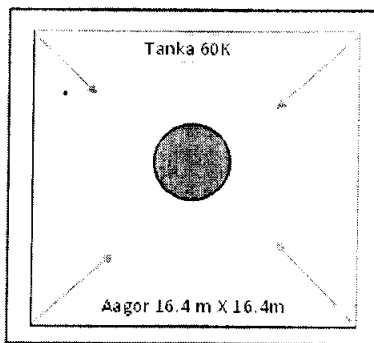

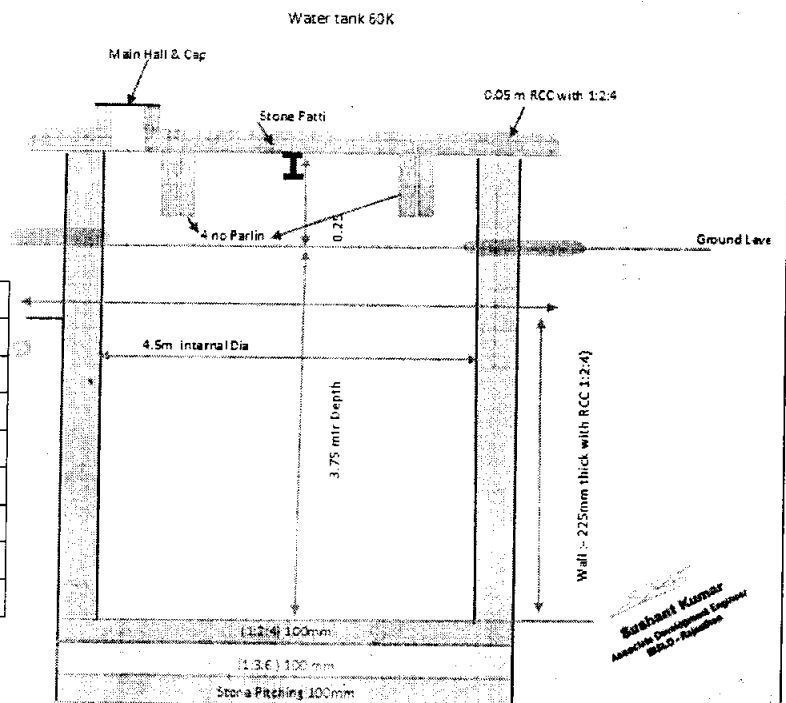

Terms & Conditions:

1. The contractor must have Registration, GST Registration and PAN Card details. The duly signed copy of each document should be submitted along with the tender.
2. **Earnest money (1% of Tender value)** should be submitted along with the tender through DD in favour of "BAIF INSTITUTE FOR SUSTAINABLE LIVELIHOODS AND DEVELOPMENT, Rajasthan." payable in Udaipur. Tender will not be accepted without earnest money. The Earnest Money will be returned to unsuccessful tenderers within a reasonable time.
3. The excavated soil will be disposed off with proper finishing,
4. Specification of Materials to be used as given below:
Cement: Ultratech or Wonder – PPC, Sand: A Grade Quality. Stone Aggregates: A Grade Quality. Other: As specified in BOQ and sample must be approved by our Engineer.
5. Excess quantity of work will not be considered. Hence, retain the size of each item as per the Work Order.
6. If in case, due to site conditions, it is necessary to change the length, width and depth of the activity, it can be done. However, the quantity of work should not exceed the quantity of work mentioned in the Work Order.
7. The payment will be made for actual quantity of work and not more than the quantity of work as mentioned in the Work Order.
8. No advance payment will be made. The running payment shall be made against Running bills i.e. the quantity of actual work done (will be measured by our Engineer). 70% amount of the measured value shall be given after submission of bill by the Contractor as a running payment.
9. The final payment of each structure shall be made after satisfactory completion of work.
10. **Penalty for delay in completion of work:** The organization may impose penalty for delay in completion of work except in case of natural calamities and law & order disturbances. The penalty amount shall be Rs. 500.00 per day. Tenderer must agree to bear penalty amount in case of delay in completion of work.
11. The rates offered by the Bidder/ Tenderer will be inclusive of all Taxes, license fee, Royalty, Octroi etc. labour and construction materials, tools and plants, water and power required for satisfactory completion of the work.
12. Any mishap, injury or damage at the site will be the responsibility of the Contractor.
13. Mention clearly that the rates are inclusive of GST or exclusive of GST and mention GST rate in %.
14. The organization reserves the right to change or amend the drawing as and when necessary and shall be notified in advance.
15. All works will be paid on the basis of actual measurements taken at site by our Engineer after satisfactory completion of the work.
16. The authority for the acceptance of the tender will rest with the organization. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer (s) shall demand any explanation for the cause of rejection of his /their tender nor can the organization undertake to assign reasons for declining to consider or reject any particular tender or tenders.
17. The competent authority of the organization for the acceptance of the tender reserves the right to divide the tender amongst more than one tenderer, if deemed necessary.
18. **The Retention money/Security money:** The 5% amount (including Earnest money) will be retained for a period of 12 months (Defect liability period / Maintenance period) after the period of completion. It will be returned without bank interest after completing the maintenance work, if required.
19. **Defect liability period / Maintenance period:** The maintenance period will be 12 months for each unit from date of satisfactory completion of the work. In case, defects are found after completion of the work, the contractor shall immediately repair the defects free of cost up to 12 months after completion of the work. Contractor shall not claim any amount for repair of the work.
20. The selected Contractor cannot subcontracted i.e. allot work to other contractors or petty contractors. In such a case, the Work Order will be cancelled and no payment will be made to the selected contractor.
