1. Quoted Price:

- The contract shall be valid up to 31/03/2027 for the above described products.
- The bidder shall quote for goods / services in the attached format of quotation;
- All duties, taxes, F.O.R. and other levies payable by the bidder shall be included in the goods / services and shall stand final.

- d. The rates quoted for each goods / service shall be fixed for the duration of the contract and shall not be subject to adjustment.
 - e. Corrections if any shall be made by crossing out, initialing, dating and rewriting.
 - f. The prices shall be quoted in Indian Rupees only
 - g. The work quantity may vary.
 - h. Estimate is subject to change in future Orders.
 - i. Bidder has to mention location (s) of work where service can be provided.
2. **Each bidder must submit only one quotation. Bidder shall not contact other bidders in matters related to this Quotation**
3. **First priority will be given to Manufacturer/Authorised Distributor.**
4. **Validity of quotations:**
 - a. The quotation shall remain valid up to 31/03/2027.
5. **Evaluation of quotations:**
 - a. Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed and conform to the terms & conditions and specifications in the following manner.
 - b. The evaluation will be done exclusive of GST.
 - c. The evaluation would be done for all the goods / services put together. The items for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly. We will award the contract to the responsive bidder whose total cost for all the items put together is the lowest.
 - d. Compare terms & conditions and specifications
6. **Award of contract:**
 - a. Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 4 (b) above.
 - b. Purchaser prior to the expiry of the validity period of the quotation will notify the bidder whose quotation has been accepted for the award of contract. The terms of the accepted offer shall be incorporated in the Purchase Order or Work Order.
 - c. Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations any time prior to the award of the contract.
7. **Payment shall be made after 15 days of delivery of goods.**
8. **Normal commercial guarantee / warranty shall be applicable to the supplied goods.**
9. **Cost of Procurement Processing:**
 - a. The bidder shall pay a "Tender Fee" of **Rs.500/-** only Bhim UPI VPA /QR Code through a detailed process enclosed as Annexure. Prior to submission of the Bid, the Transaction No. and dates are to be mentioned.
10. **Earnest Money Deposit:**
 - a. EMD for this tender will be 2% of the total cost of the PO. BISLD Nashik will compare all the bids and the Purchase Committee will award a contract to the Selected Vendor. Selected Vendor will be informed of the selection for supply of goods/services by E-mail. Selected Vendor has to transfer the EMD amount within two working days and inform about the Transaction No. and date by return E-mail. After confirmation of EMD amount being deposited in BISLD Bank Account, BISLD will issue the Purchase

Order/Work Order. In case of failure to pay EMD, BAIF Livelihoods Purchase Committee reserves the right to decide further course of action.

The same will be refunded (interest free) after obtaining the work completion report of the total scope of work or guarantee/warranty period, for at least one monsoon season period whichever is applicable. The earnest money shall be liable to be forfeited, if the successful bidder, after submitting the tender rescinds from or modifies the offer after acceptance of the tender.

After acceptance of Work Order/Purchase Order and payment of EMD, if work is not completed or material is not supplied within the validity period of the Work Order/Purchase Order, the Vendor will not be eligible for refund of EMD and will also not be eligible to participate in the future tender process of BAIF for a period of one year.

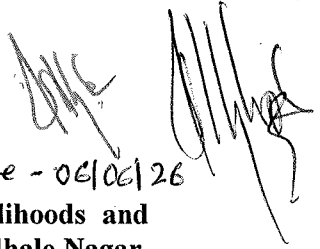
