Terms & Conditions:

1. The vendor must have their registration, GST registration, and PAN documents. The duly signed copy of each document shall be submitted along with the tender.
2. Earnest money (2% of Tender value) shall be submitted along with the tender through DD in favour of **“BAIF INSTITUTE FOR SUSTAINABLE LIVELIHOODS AND DEVELOPMENT, U.P.”** payable in Prayagraj. Tenders will not be accepted without the earnest money. The Earnest Money will be returned to unsuccessful tenderers within a reasonable time.
3. None of the advance amount shall be given.
4. The earnest money shall be retained as Security money for 24 months against the maintenance of the Portable solar irrigation pump trolley-based system.
5. The retained amount shall be refunded without any bank interest after 24 months.
6. **Defect liability period / Maintenance period:** The maintenance period will be 24 months for each unit from the date of satisfactory completion of work. In case defects are found after completion of work, the vendor shall immediately repair the defects free of cost up to 24 months after completion of work. The vendor shall not claim any amount for repair work.
7. The “Insurance” of the entire structure must be done for 3 years by the Vendor. The cost will be included in the tender value.
8. **Penalty for delay in completion of work:** The organisation may impose penalties for delay in completion of work, except in cases of natural calamities and law and order situation. The penalty amount shall be **Rs. 500 per day**. The tenderer must agree to bear the penalty amount for any delay in the completion of the work.
9. The rates offered by the Bidder/ Tenderer will be inclusive of all Taxes, License fees, Royalty, Octroi, Labour, Construction Materials, all Tools and Plants, Water, and Power required for satisfactory completion of the work.
10. Any mishap, injury, or damage occurring at the site, will be the responsibility of the vendor.
11. It should be mentioned clearly that the rates are inclusive or exclusive of GST, and the GST rate in % should also be mentioned.
12. All payments will be made only after satisfactory completion of the work.
13. The authority for the acceptance of the tender will rest with the organisation. It shall not be obligatory on the said authority to accept the lowest tender or any other tender and no tenderer (s) shall demand any explanation for the cause of rejection of his/their tender nor will the

organisation undertake to assign reasons for declining to consider or reject any particular tender or tenders.

14. The competent authority of the organisation for the acceptance of the tender reserves the right to divide the tender amongst more than one tenderer, if deemed necessary.
15. The payment will be made for the actual quantity of work, but not more than the quantity of work of a Portable solar irrigation pump trolley-based system as mentioned in the work order.
16. The final payment shall be made after satisfactory completion of work on production of tax invoice with warranty card.
17. The 2 HP Portable Trolley-based Solar Pump System shall be supplied, installed, tested, and commissioned as a complete unit, including solar PV modules, portable trolley structure with wheels, DC/AC solar pump, controller, cables, connectors, safety devices, and all other accessories required for satisfactory operation.
18. The trolley structure shall be sturdy, corrosion-resistant, and designed for easy transportation and movement across agricultural fields. The wheels, frame, and mounting arrangement shall be capable of withstanding normal field conditions without affecting the performance of the solar pumping system.
19. The solar PV modules, pump, controller, and all associated components shall be from approved manufacturers and shall comply with the latest MNRE/BIS/IEC standards, wherever applicable.
20. The Vendor shall provide complete installation, testing, demonstration, and operational training to the end users and field staff regarding safe operation, routine maintenance, and handling of the portable solar pump system.
21. The Vendor shall ensure that the system achieves the specified discharge and performance parameters under standard operating conditions. Performance testing shall be carried out in the presence of the field engineer before final acceptance.
22. Any defective material, component, or equipment observed during the warranty period shall be repaired or replaced by the Vendor at no additional cost to the organisation within the stipulated time.
23. The Vendor shall submit all relevant documents, including technical datasheets, warranty certificates, insurance details, AMC terms, operation and maintenance manuals, test certificates, and commissioning reports before release of the final payment.
24. The Vendor shall be responsible for the safety of materials and equipment during transportation, installation, and commissioning until formal handover of the system.
25. The field engineer reserves the right to inspect, verify, reject, or seek replacement of any material not conforming to the approved specifications, quality standards, or tender requirements.
26. The Vendor shall provide after-sales service support during the warranty and AMC period and shall attend to any complaints or breakdowns within the specified response time as agreed in the contract.
